REGISTRATION POLICY

Please read carefully as our registration policy has changed.

Final payments are due 8 weeks before arrival. A final bill, health form and other information will be sent to you in April. There is a \$35.00 late fee and a \$30.00 NSF fee. Late payments must be made 4 weeks before arrival. After that, payment must be made in cash or money order. If you need to make payment arrangements, contact us before your final bill is due.

Registrations made within 8 weeks of arrival must be paid in full.

A cancellation fee of \$50 is charged up to May 15. After that date, the full deposit is forfeited. This includes dropping a session. It is very difficult for us to replace campers after May 15.

Please choose your session(s) carefully and coordinate it with other vacation plans. Bringing campers late to start the session or picking them up early negatively impacts the camp experience for campers and their units. It also creates extra work for our staff on already busy days. All campers must start their session on Check-In day and leave on Check-Out day at the correct time. Late arrivals and early departures are strongly discouraged except for emergency reasons. Leaving during the camp session is only permitted for emergency reasons.

Non-emergency late arrivals, early departures and leaving during the session must be approved by the Director and are subject to a \$40 service charge.

All campers staying for two sessions must be visited on Visiting Day from 11:00 am to 4:00 pm. Campers truly enjoy and benefit from a visit with family members or family friends, and the Onas staff needs this time to prepare for the next session and cannot supervise campers. Please inform the Director if someone other than a parent will be visiting.

This Registration Policy has been written so that we may continue to create a peaceful, fun, stress-free and affordable experience for our campers. While we fully understand the pressures family schedules are subject to, please carefully choose the session dates for your camper and allow him/her to experience the whole wonderful session from beginning to end.
